MINUTES OF THE BENTON COUNTY ELECTION COMMISSION

May 29, 2012

Commission members present: John Brown, Jr., and Russ Anzalone

Chairman Brown called the meeting to order at 4:00 P.M.

Coordinator's Update:

Kim Dennison stated that she was waiting for the media and paper ballots to be returned from ES&S for the General Primary Run-Off Election to be held June 12, 2012. When the media is received, L&A testing will begin.

New Business:

- A. Order to Establish Official Polling Locations for the General Primary Run-Off Election to be held June 12, 2012:
- B. Chairman Brown stated that there are seventeen (17) polling locations and the run-off is for JP District #15 and Constable District #1. Chairman Brown made a motion to accept the polling locations for the General Primary Run-Off Election, seconded by Commission Anzalone. Motion carried by voice vote.
- C. Order to Establish Early Voting Locations for the Republican General Primary Run-Off Election to be held June 12, 2012:

Chairman Brown stated that early voting locations would be at the Bentonville and Rogers County Clerk's Offices. Chairman Brown made a motion to accept the early voting locations for the General Primary Run-Off Election, seconded by Commission Anzalone. Motion carried by voice vote.

D. Order to Establish the Election Officials for the General Primary Run-Off Election to be held June 12, 2012:

Chairman Brown made a motion to accept the Election Officials to conduct the June 12, 2012 General Primary Run-Off Election, seconded by Commissioner Anzalone. Motion carried by voice vote.

E. Order to Appoint Election Officials to Process, Count, and Canvass Absentee Ballots for the General Primary Run-Off Election to be held June 12, 2012:

Chairman Brown stated that the Election Commission has reviewed and approved the Election Officials to process, count, and canvass absentee ballots for the General Primary Run-Off Election. Chairman Brown asked for comments. There being no further comments, Chairman Brown made motion to accept, seconded by Commissioner Anzalone. The commissioners approved and signed the order.

F. Order to Sign Changing The Polling site from New Life Christian Center to Centerton Fire Department:

Chairman Brown made a motion to move Precinct 22, New Life Christian Center to the Centerton Fire Department for the General Primary Run-Off Election. Motion carried by voice vote.

G. Amended Order to Establish the Official Voting Polling Sites for the June 26, 2012 Bentonville School District Special Election:

Chairman Brown made a motion to accept the amended Official Voting Polling sites for the June 26, 2012 Bentonville School District Special Election, seconded by Commissioner Anzalone. Motion carried by voice vote.

H. Discussion of a Special Bond Election for the City of Springdale Ordinance #4592 to be held August 14, 2012:

Chairman Brown stated that the City of Springdale is requesting a special bond issue election to be held on August 14, 2012. Chairman Brown stated that the commissioners do not have to approve or sign for the Special Bond Election but it is to make the commissioners aware of the election.
