MINUTES OF THE BENTON COUNTY ELECTION COMMISSION

June 8, 2012

Commission members present: John Brown, Jr., Russ Anzalone, and Robbyn Tumey

Others present: Kim Dennison and Sharon Rose

Chairman Brown called the meeting to order at 4:02 P.M.

Coordinator's Update:

Kim Dennison stated that Republican General Primary Run-Off Election is ready. Chairman Brown asked Kim if the machines were ready for the Bentonville School District Special Election. Kim responded that the machines were ready, but the bags have not been packed and early voting begins on June 19th.

New Business:

- A. Order to approve L&A Testing for the Republican General Primary Run-Off Election to be held June 12, 2012: Chairman Brown asked Commissioner Anzalone to review the Certification of Logic and Accuracy Testing Results before he signed. Commissioner Anzalone reviewed the certification and had no questions. Chairman Brown signed the certification.
- B. Order to approve L&A Testing for the Bentonville School District #6 Special Election to be held June 26, 2012: Chairman Brown asked Commissioner Anzalone to review the Certification of Logic and Accuracy Testing Results before he signed. Commissioner Anzalone reviewed the certification and had no questions. Chairman Brown signed the certification.
- C. Ballot draw for the City of Siloam Springs Primary Election: Chairman Brown stated that the City of Siloam Springs will have their election on August 14, 2012. Chairman Brown stated that three (3) individuals were running for Board of Director, Position 7, and three (3) individuals were running for the Mayor's position. Chairman Brown set June 11, 2012 at 4:00 P.M. for the ballot draw. Chairman Brown stated that Board of Directors, Positions 5 and 6 has two (2) individuals, those positions will be drawn in an August, 2012 ballot draw, which is the draw for the Municipal Elections and will be on the November ballot. Chairman Brown asked

Commissioner's Tumey and Anzalone for August 23, 2012 at 3:00 P.M. for the ballot draw. Kim stated that the ballot draw will be lengthy due to all Benton County city filings and filing begins July 17, 2012.

- D. Discussion on City of Springdale Election to be held August 14, 2012: Chairman Brown asked for comments for the upcoming election. Kim stated that the Bethel Heights City Hall was available for the City of Springdale Election to be held on August 14, 2012.
