MINUTES OF THE BENTON COUNTY ELECTION COMMISSION

April 8, 2014

- A. Order To Change Polling Site Location From The Rogers First Church Of The Nazarene (Pct.43) to Trinity Grace Church (Pct. 71), Rogers, for the Preferential Primary Run-Off Election to be held June 10, 2014: Chairman Brown stated that the Rogers First Church Of The Nazarene had stated previously that their facility would not be available for the Preferential Primary Run-Off Election that is to be held on June 10, 2014. Commissioner Anzalone asked Election Coordinator Kim Dennison how far Trinity Grace Church was from the Rogers First Church of The Nazarene. Kim stated approximately three (3) miles and this move would only occur if there is a run-off at the Rogers First Church of The Nazarene (Pct. 43).
