MINUTES OF THE BENTON COUNTY ELECTION COMMISSION

March 9, 2023

Election Commission members present: Russell J. Anzalone and Wynne Gregory Day

Chairman Anzalone called the meeting to order at 1:00 p.m.

Minutes:

Chairman Anzalone asked if there were any additions or corrections to the minutes from March 2, 2023. There being none, Commissioner Day made a motion that the minutes be approved as submitted, seconded by Chairman Anzalone. Motion carried by unanimous voice vote.

New Business:

A. Order to Establish Election Day and Early Voting locations for the 2023 May Annual School Election to be held May 9, 2023: Chairman Anzalone stated that there would be eighteen (18) Election Day locations opened for the 2023 Annual School Election. Chairman Anzalone asked for discussion. There being no discussion, Commissioner Day made a motion to accept the Election Day locations for the 2023 May Annual School Election to be held May 9, 2023, seconded by Chairman Anzalone. Motion carried by unanimous voice vote.

Chairman Anzalone stated that the three (3) early voting locations are as follows: (1) Benton County Administration Building; (2) Benton County Clerk's office in Siloam Springs; and (3) Benton County Election Commission office. He added that all locations would be opened Tuesday, May 2 through Friday, May 5 and Monday, May 8 from 8:00 a.m. to 4:30 p.m. Chairman Anzalone asked for discussion. There being no discussion, Commissioner Day made a motion to accept the three (3) early voting locations for the May 9, 2023 election, seconded by Chairman Anzalone. Motion carried by unanimous voice vote.
